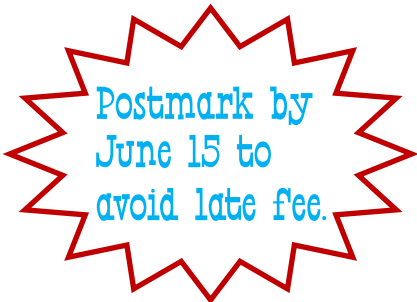

I understand and acknowledge that there are certain hazards and risks associated with my child's participation in the 4-H District 10 Horse Show. These risks may result in injury, death or damage to property. I understand and accept such risks, and thus waive all claims, demands, and causes of action against the State of Colorado, Board of Governors of the Colorado State University System, Colorado State University, Extension offices and their members, officers, employees, agents and volunteers acting on their behalf. It is agreed that in no event will the superintendents, show management, or the District 10 Horse Show Committee be held responsible for any loss or damage to the property, animals or per of entrant or other person whether said loss or damage shall arise from negligence or any other causes. I understand that I am solely responsible for any costs arising out of any injury or property damage sustained through my child's participation in the District 10 4-H Horse Show. It is the responsibility of the exhibitor to pay for and remove any animal injured or killed by the exhibitor as determined by the judge and/or show manager. The owner of the livestock shall determine the price of the animal(s).

I have had sufficient time to review and seek explanation of the provisions contained above, have carefully read them, understand them fully, and agree to be bound by them. After careful deliberation, I voluntarily give my consent to my child's participation and agree to the terms contained in this document.

Signature of this entry authorizes participation in the District 10 4-H Horse Show and agreement to abide by the rules as outlined in the Colorado 4-H Horse Show Rule Book and District 10 4-H Horse Show Rules (pages 6-7) and follow the state 4-H Code of Conduct.

**I hereby release** and waive any and all liability, claims, demand, losses, damages, costs, expenses, attorney fees, judgments of any kind whatsoever against, and will indemnify, save and hold harmless those associated with the organization or production of the associated event, including but not limited to, Montrose County and all their respective members, volunteers, representatives, officers, officials whether elected or appointed, employees, attorneys, insurers, agents, assigns of each named entity, and Event organizers (collectively "Releasees"), in connection with, arising out of, or by any reason related to participation in events or activities, including those *involving animals of any type*, associated with the above mentioned event.
